**1.2 Venue & Equipment:** Registrants are expected to adhere to all instructions and guidance by Sydney Sixers coaches, staff, and other representatives in relation to treatment of event venue and venue property and equipment. Cricket NSW shall not be liable for any loss or damage to event venue, property and equipment resulting from any act or omission of a participant and will be entitled to recover the cost of any such loss or damage and incidental expenses including legal costs from the participant responsible for the loss or damage.

**1.3 Cancellation, and Replacements:** Once your registration is accepted you cannot cancel your booking. No, credits or exchanges are allowed except as expressed in this Agreement or required by law. In the circumstance that the event is cancelled due to wet weather, participants will be notified via phone call. Sydney Sixers Girls Colour Blast also reserves the right to cancel any registrations at any time if, in the Club's opinion, a participant engages in disruptive behaviour which is deemed inappropriate (physically or emotionally), or likely to be prejudicial, to the interests of fellow participants, coaches, staff members or other related parties.

**1.4 Privacy Policy:** Sydney Sixers Girls Colour Blast respects the privacy of the personal information it collects, uses and discloses in relation to participants. The personal information that the Club collects is used for the purpose of processing your registration and providing you with cricket related information and offers from Sydney Sixers. A copy of Sydney Sixers Privacy Policy is available to any participant upon written request.

**1.5 Use of Images:** Sydney Sixers advises that photographic and film images of participants at each event may be used for the purpose of promotion and marketing of the game. If you do not wish images of the participant to be used, you must advise us in writing at time of submitting your registration form.

**1.6 Liability for Injury:** In submitting their registration form the participant and their parent or guardian acknowledges that participating in the event carries with it inherent dangers and/or risks of physical injury, including serious injury such as permanent disability, paralysis and even death. The participant and their parent or guardian understand that the participant is voluntarily participating in the event with knowledge of the potential dangers and/or risks involved. To the fullest extent permitted by law, the participant and their parent or guardian waive, release, indemnify and forever discharge Sydney Sixers (as well as their Directors, employees, sponsors, volunteers, agents and representatives) from and against any and all claims and/or loss and/or cause of action arising from any injury, death, loss or damage of any kind suffered by the participant or any third party arising directly or indirectly from the participant's involvement or participation in the camp and/or resulting from any services provided by Sydney Sixers.

**1.7 Liability for Personal Items:** Whilst Sydney Sixers use all reasonable endeavours to select appropriate secure locations for our events, participants and their parents or guardians acknowledge that Sydney Sixers takes no responsibility for personal items that are lost. Where possible, if any items are found by Sydney Sixers Girls Colour Blast staff, Sydney Sixers holds a lost property service to allow goods to be returned to rightful owners.

**1.8 Transport and collection:** Parents or guardians are responsible for arranging transport of the participant to and from the venue and for prompt collection of the participant from the venue following conclusion of event. Sydney Sixers bear no responsibility in those respects.

**1.9 Ticket Purchase:** The Ticketek code word 'colourblast' can only be used for purchase of ONE Adult ticket with the ONE free Child Ticket. This code word is not to be distributed to any other parties and is strictly for the Sydney Sixers Girls Colour Blast participants.
