



Sixers Girls Cricket Clinic Terms and Conditions

1.1 Product: Sydney Sixers Girls Cricket Clinic reserves the right to change any of the clinic package details including locations, dates and times at any point in time. Sydney Sixers reserves the right to not accept any registration for clinics in its absolute discretion.

1.2 Venue & Equipment: Registrants are expected to adhere to all instructions and guidance by Sydney Sixers coaches, staff, and other representatives in relation to treatment of camp venue and venue property and equipment. Cricket NSW shall not be liable for any loss or damage to clinic venue, property and equipment resulting from any act or omission of a participant and will be entitled to recover the cost of any such loss or damage and incidental expenses including legal costs from the participant responsible for the loss or damage.

1.3 Cancellation, Refunds and Replacements: Once your registration is accepted you cannot cancel your booking. No refunds, credits or exchanges are allowed except as expressed in this Agreement or required by law. In the circumstance that the camp is cancelled due to wet weather, fees will be credited to the Sixers Girls Coaching Clinic only. Please note that credits not used at the next clinic are forfeited and cannot be refunded. 1 day wet weather cancellation = \$60 credit. Credits are not pro-rated if a clinic is cancelled during the day. If there is more than one and a half hours play, no credits are applied. If there is less than one and a half hours play, a full day credit will be issued. If the clinic is changed in accordance with clause 1.1, you will be able to attend the next clinic free of charge, provided you did not attend the clinic that was changed. Sydney Sixers also reserves the right to cancel any registrations at any time if, in the Club's opinion, a participant engages in disruptive behaviour which is deemed inappropriate (physically or emotionally), or likely to be prejudicial, to the interests of fellow participants, coaches, staff members or other related parties.

1.4 Privacy Policy: Sixers Girls Cricket Clinic respects the privacy of the personal information it collects, uses and discloses in relation to participants. The personal information that the Club collects is used for the purpose of processing your registration and providing you with cricket related information and offers from Sydney Sixers. A copy of Sydney Sixers Privacy Policy is available to any participant upon written request.

1.5 Use of Images: Sydney Sixers advises that photographic and film images of participants at each clinic may be used for the purpose of promotion and marketing of the game. If you do not wish images of the participant to be used, you must advise us in writing at time of submitting your registration form.

1.6 Liability for Injury: In submitting their registration form the participant and their parent or guardian acknowledges that participating in the clinic carries with it inherent dangers and/or risks of physical injury, including serious injury such as permanent disability, paralysis and even death. The participant and their parent or guardian understand that the participant is voluntarily participating in the clinic with knowledge of the potential dangers and/or risks involved. To the fullest extent permitted by law, the participant and their parent or guardian waive, release, indemnify and forever discharge Sydney Sixers (as well as their Directors, employees, sponsors, volunteers, agents and representatives) from and against any and all claims and/or loss and/or cause of action arising from any injury, death, loss or damage of any kind suffered by the participant or any third party arising directly or indirectly from the participant's involvement or participation in the camp and/or resulting from any services provided by Sydney Sixers.

1.7 Liability for Personal Items: Whilst Sydney Sixers use all reasonable endeavours to select appropriate secure locations for our holiday clinics, participants and their parents or guardians acknowledge that Sydney Sixers takes no responsibility for personal items that are lost. Where possible, if any items are found by CNSW staff, Sydney Sixers holds a lost property service to allow goods to be returned to rightful owners.
